<p>Principles for the allocation of funding</p> <ul style="list-style-type: none"><li>• Pupil Premium funding will be used to provide additional educational support to improve progress and to raise the standard of achievement for this group of pupils.</li><li>• The funding will be used to narrow the gap between the achievement of these pupils and their peers, both in school and nationally.</li><li>• As far as its powers allow, the school will use the additional funding to address any underlying inequalities between children eligible for Pupils Premium and others.</li><li>• We will ensure that the additional funding reaches the pupils who need it most and that it makes a significant impact on their education and lives.</li><li>• We ensure that teaching and learning opportunities meet the needs of all pupils.</li><li>• Limited funding and resources means that not all children will be in receipt of pupil premium interventions at the same time.</li></ul>					

**SATS and Data Summary**

**Due to the Covid-19 pandemic and the partial closure of school, most standard assessments did not take place in the usual way. Therefore, the usual performance data is not available.**

**The school worked hard to provide a good standard of education for pupils in school and those working remotely.**

<b>Barriers to future attainment for pupils eligible for Pupil Premium funding</b>	
1	Pupils eligible for Pupil Premium funding generally enter school well below a typical level of development for their age.
2	Pupils enter school with poor language and communication skills.
3	Many pupils are not 'school ready' when they enter the Foundation Stage Unit.
4	School attendance for this group of pupils is often lower than other pupils within school.
5	A number of pupils entitled to Pupil Premium need a 'whole family' approach to overcome barriers to learning.
6	Many pupils eligible for funding have limited life experiences when compared with more affluent peers.
External barriers that may require action outside of school.	
7	The support of a number of outside agencies e.g. social workers, CAMHs EWO, Parenting support is regularly required to support the most vulnerable families.

<p>Providing small group work or extra adult support for some pupils entitled to PP funding with a focus on overcoming gaps in learning to help them make improved progress and to raise their standards of achievement</p>	<p>Pupils eligible for PP make rapid progress and the gap between this group and other pupils in the cohort diminishes.</p>	<p>The use of targeted support throughout school impacts on individual pupil progress. Cohort analysis, prior to lockdown, shows that eligible pupils, who do not have other additional needs, are making good progress in comparison with their cohort peers.</p> <p>2020/2021 will continue with this support with a greater emphasis on reviewing and adapting strategies used with individual pupils. There is a need to 'close gaps' for many pupils due to lost learning time and disadvantage pupils may have been more adversely affected than other students. This will be monitored</p>

Interventions and support throughout school for eligible pupils in supporting pupil progress. This will primary focus upon reading and phonics for younger pupils and reading and mathematics for older ones.  This is demonstrated through children's work and assessment data.
Our work through the Pupil Premium strategy will be aimed at accelerating progress, moving pupils entitled to PP funding to at least age related expectations. Initially this will be in English and Mathematic	Pupils eligible for PP funding will achieve at least in line with their peers across school. At the end of KS1 and KS2 the gap between our PP pupils and other Non-PP pupils nationally, will narrow.	Due to uncertain times ahead and the possibility of further school closure, we are not setting specific targets this year. We are instead constantly reviewing progress and adapting provision to support accelerated progress for pupils.
